PARCEL NUMBER CHANGES

You ran the title search, ordered a Flood Certificate, submitted docs, ordered Tax service, and closed the loan... in whatever order. Now it's a year or two later... or five or ten... and you are looking at your Delinquent Tax Report and one of your borrowers is delinquent on their property taxes... but that's not the parcel number you submitted when you ordered!

In case you didn't know, parcel numbers change... and title doesn't always catch it. Maybe it was a database format mismatch; maybe someone just submitted the old title, thinking, "parcel numbers never change." Or, maybe the change occurred after the report was submitted. But parcel numbers do change.

Sometimes property owners submit paperwork to the county to combine their parcels so they only receive one tax bill. Sometimes it is necessary for the county to administratively change the APN due to map page layout and mainframe computer limitations. Other reasons are Lot Line Adjustments, Parcel Map Waivers, Agricultural Land Contracts, Tax Rate Code changes, and many others.

At Nationwide, we verify APNs with the county every time we check taxes and also inbetween, like when we receive an order. We don't rely on title to be correct, because they are not more often than many people realize.

Parcel numbers change, split, combine, expire, and are terminated. It is critical to our reporting that we capture this for our clients.

When you submit an order for Tax or Flood, it's usually easy to check if the parcel number you are submitting is accurate, as most counties have website access to that information. When we record parcel number changes in our records, it's prudent for you to record those changes in your records to avoid possible confusion later.

New Tax-Tie Ordering Features

On January 16, 2012 Nationwide Real Estate Tax Service, Inc. released a new version of its online ordering system: Tax-Tie. The changes were designed to improve user functionality while retaining the easy-to-use design that our customers appreciate.

CHANGE #1: VIEW ORDERS

You can now delete orders directly from the **View Orders** menu option. Deletions may take up to 5-7 days to clear through our system.

We have also added navigating convenience from the top of most pages.

CHANGE #2: VIEW REPORTS

A new menu option has been added, **View Reports**, whereby you can access and print your most recent Delinquent, Incorrect Info, and Different Owner reports, in addition to any Delinquent Letters you have ordered.


Remember, the information on these uploaded reports is only as good as the day posted and does not automatically update over time. You can contact our Tax Dept to check up on any accounts of concern.

CHANGE #3: MANAGE USERS

You no longer need to call in to our office to get a USERNAME and PASSWORD assigned to other colleagues in your office. You now have the ability to view, edit, add, and delete users and passwords, as necessary.

Your current USERNAME and PASSWORD will be automatically assigned as High security level, which gives full access to all Tax-Tie user functions. Medium security level users have access to all Tax-Tie functions except user management. Low security level users can only view and place orders (no deletions).

Assign users and passwords as you see fit. We will be notified of all changes, so you can call in if you need to retrieve any user logins that were forgotten.



CHANGE #4: AUDIT REPORTS

Tired of calling in to get an audit report of a certain type? Run your own and save time!

Audit reports will be accurate up to the day prior. You can run a Tax/Flood, Flood Zone Only, or Expired Loans audit report. Loans that have been deleted will not show up on these reports unless deleted within the deletion window (allow 5-7 days for deletions to process).

Each audit option allows you to specify the date range. Audits can be printed directly from the web in report form or exported into *Excel* for easy data sorting and saving on your computer.

Detailed instructions for these new features can be printed from the main Tax-Tie Ordering Options menu.
